



2012 OFFICIAL EMERALD COAST PARROT HEAD CLUB CHILI COOK-OFF RULES



1. Anything goes recipe: This is for fun, so there are no basic recipe rules. Red chili, white chili, green chili... Bring on your best! Chili is to be prepared off site and brought heated and ready to eat, and will be judged on set criteria by a panel of celebrity judges, and the People's Choice award.
2. Each chili contestant will pay a \$20 Entry Fee (\$45 for non-Parrot Head member to include \$25* membership fee to ECPHC), and will receive 1 admission bracelet to the event. Each chili contestant must be aged 21 years or older. Chili contestant will wear the admission bracelet as his/her entry to the cook-off; any extra persons associated with chili contestant must pay the price of admission upon entry. Chili contest open to current Parrot Head Club members **of any affiliated Parrot Head Club**. * \$5 thru March 31, \$20 for April 1-March 31
3. Each chili contestant will cook and have available a minimum of 3 gallons of competition chili; however, the more the better your chances to win for People's Choice with more votes.
4. Chili must be in place and set up **no later than 3:30 pm** date of event (no rain date). Only contestants who have preregistered will be allowed to set up chili.
5. Chafing dishes will be set up for each entry; you may bring more chili to add to the pot as the night progresses (plan to bring a container to keep the additional chili warm during cook-off; chili **MUST** be kept at a safe temperature, ABOVE 140 °).
6. Each chili must be named, and a written recipe must be available upon request by judges. At the discretion of the judge, chili contestants may be required to taste their chili before turning it in for judging. Chili contestants are responsible for preparing and serving chili in a safe & sanitary manner.
7. Contestants are responsible for supplying all of their own utensils & products relating to their chili submission and maintenance of its proper temperature for serving. Spoons and cups for use in serving chili to the general public and judges will be provided. Condiments will not be provided; however, competitors may supply any sides they wish to enhance their product.
8. Each contestant is responsible for policing and cleaning up the area at the end of the day and removing all items from the area. No items shall be allowed to remain after the close of the cook-off.
9. No outside beverages of any kind are allowed in the facility; beverages are available for purchase inside Fudpucker's.
10. Thank you for promoting American Cancer Society Relay for Life with your participation; the more people you encourage to attend, the more people vote for your chili & learn about Relay for Life.
